## DEBO® Compact Laminate TEN YEAR STANDARD LIMITED WARRANTY

### 1 Limited Warranty.

DEBO® offers a warranty to the buyer (the "Buyer") of its panels. This warranty ensures that the panels will conform to the performance specifications published on [www.debolaminates.com](http://www.debolaminates.com) at the time of delivery, for a period of ten (10) years from the date of delivery to the Buyer. The terms and conditions of this limited warranty applicable to the panels are solely valid as explicitly stated at [www.debolaminates.com](http://www.debolaminates.com) on the date of first shipment to the Buyer.

### 2 Remedy.

If the panels do not conform to this limited warranty, DEBO® reserves the right, at its discretion, to either repair the defective panels or provide replacement panels. The warranty period for the repaired or replaced panels shall be the remaining duration within original limited warranty period. If DEBO® decides to repair the defective panels, the Buyer must permit DEBO® to undertake the repair. If DEBO® opts to provide new panels, DEBO® is obligated only to supply panels that are as closely approximating the original color of the delivered panels as possible and is not required to provide panels of the exact same color.

### 3 Limited Warranty Conditions.

This limited warranty will be void and/or considered revoked if any of the following conditions are not strictly comply with:

1. The Buyer has paid the full price for the panels and fulfilled all its obligations towards to DEBO® (payment obligations);
2. The panels are installed in accordance with all applicable building codes, standards, laws, and regulations;
3. The storage, transportation, processing, application, manufacture, installation, and/or maintenance instructions as specified on [www.debolaminates.com](http://www.debolaminates.com) at the time of DEBO®'s delivery of the panels to the Buyer are strictly adhere to;
4. The Buyer must inspect the panels immediately upon receipt and notify DEBO® in writing of any obvious defects (defects visible to the naked eye or that should have been apparent to the Buyer), within five (5) days of receipt, or within five (5) days after the initial inspection if the panels are stored according to the instructions on [www.debolaminates.com](http://www.debolaminates.com) for up to one year;
5. The Buyer must not modify or alter the panels upon receipt unless changes are necessary for correct installation in compliance with all applicable building codes and standards;
6. For claims related to reasons other than the obvious defects mentioned above, the Buyer must notify DEBO® in writing within five (5) days of discovering or reasonably being expected to discover the defect, and provide proof of purchase, including this warranty card and evidence showing the panels were purchased directly from DEBO®.
7. Upon receipt of a claim under this limited warranty, the Buyer must permit DEBO® a reasonable opportunity to inspect the allegedly defective panels and must provide DEBO® with all relevant information and documentation, including installation and maintenance information.

### 4 Limitations of Damages Exclusive Remedy.

Repairing or replacing the defective panels constitutes the exclusive remedy available under this limited warranty. Except where prohibited by law, DEBO® is not liable for any incidental or consequential damages or for any breach of any other express or implied warranty. DEBO® is not responsible for any indirect losses, losses suffered by third parties, or losses covered by any insurance held by the Buyer. The Buyer shall bear all costs and expenses related to the removal and reinstallation of repaired or replaced panels, including dismantling supporting structures, repairing supporting structures, repainting or resurfacing, and similar expenses. Under this limited warranty, DEBO®'s liability is limited to the lesser of (1) Multiply the total area of the defective sheets by the price (excluding tax) paid by the buyer for the corresponding sheets on the proforma invoice. The compensation amount will decrease by 10% annually (for example, three years after the invoice date, the maximum replacement cost will be 70% of the value of the defective sheets); or (2) RMB 1,000,000 (one million Chinese Yuan). All rights and claims of the Buyer under this limited warranty shall expire ten (10) years after the Buyer receives the panels.

### 5 Exclusions.

This limited warranty does not extend to any defects in materials or components other than the panels. Additionally, it does not cover damage caused by factors that are unrelated to the production process of the panels. Such factors include, but are not limited to, improper, erroneous, or unsuitable handling and/or installation; combining or assembling the panels with other materials or components, normal weathering, exposure to corrosive elements in the atmosphere, mold, harmful cleaning agents, storms, sandstorms, natural disasters, riots, vandalism, malicious damage, impacts, misuse, abuse, accidental damage, acts of war, terrorism, civil disobedience, or any "force majeure" events.

### 6 Disclaimer.

Except as expressly provided herein, the panels are provided "as-is," and DEBO® disclaims all other express, implied, or statutory warranties, including, without limitation, warranties of merchantability, fitness for a particular purpose, or any warranties arising from trade usage or custom. This limited warranty is the sole and exclusive warranty provided by DEBO® and supersedes all other warranties, whether based on oral or written statements. In no event will DEBO® be liable for any claims, expenses, or losses arising from non-compliance with applicable codes or industry standards. All other Buyer claims are excluded. Any transfer or assignment of Buyer rights under this limited warranty is null and valid.

### 7 Governing Law and Jurisdiction.

This limited warranty is governed by and construed in accordance with the laws of the People's Republic of China. The courts of Shenzhen, China, shall have exclusive jurisdiction over disputes arising from this limited warranty. International treaties and uniform laws related to the sale of goods (including but not limited to the United Nations Convention on Contracts for the International Sale of Goods) are excluded.

### 8 Legal Action.

If the Buyer does not commence legal action within one (1) year after discovering or reasonably should have discovered that the panels do not conform to this limited warranty, the Buyer shall not be entitled to pursue any legal action, lawsuit, or proceeding against DEBO® regarding or arising from this limited warranty.
